INSTRUCTIONS FOR THE SUBMISSION OF APPLICATION FORMS

Selection Criteria:

- Must be a permanent resident of Molteno or Sterkstroom.
- Proof of residence required (e.g., municipal letter, affidavit).
- Must currently be in their final year of study or have completed a qualification at a public university, university of technology, or TVET college.
- Must provide academic transcript, proof of qualification (or letter confirming completion), and official debt statement from institution or NSFAS.
- Only historical student debt will be considered; any future or to-be-acquired debt will not be eligible.
- Only debt incurred for tuition purposes will be considered
- Priority may be given to graduates in fields aligned with Economics & Management Sciences, Engineering & the Built Environment, Information and Communication Technology (ICT), Accounting, and Science.


Terms and Conditions:

- A certified copy of the ID, proof of residence, academic transcript and qualification, debt statement from the institution, income affidavit or payslip, and a motivation letter (maximum one page) must be submitted.
- Fees will be paid directly to the institution.
- Applications reviewed by Dorper Wind Farm's SED Committee.
- Priority given to financially vulnerable households, graduates contributing to local development, and applicants with community service experience.
- Beneficiaries may be asked to participate in local mentorship or career guidance programmes and volunteer in Dorper Wind Farm-supported community initiatives.
