#### 1. INTRODUCTION

This programme is designed to improve educational outcomes and learner well-being through targeted interventions in literacy, numeracy, science education, and school-based health support. Dorper Wind Farm seeks to engage service providers with proven experience in educational programme delivery, learner support, and community-based implementation. The selected provider(s) will be expected to work closely with local schools and stakeholders to ensure the programme's effectiveness, sustainability, and alignment with the wind farm's development objectives.

#### 2. SCOPE OF WORK

#### After-School Classes

- Establish and manage structured after-school classes for Maths, Literacy, and Science.
- Ensure qualified facilitators are available to support learners with homework, revision, and exam preparation.
- Monitor attendance and progress, and provide regular feedback to Dorper Wind Farm schools and parents

## **Literacy Development**

- Design and deliver literacy support interventions for leaners.
- Provide training and resources to improve reading and writing outcomes among learners.

# **Numeracy and Science Support**

- Implement learner-focused activities and support mechanisms to strengthen Maths and Science understanding.
- Facilitate workshops, tutoring, or enrichment programmes targeting key learning gaps.

## Monitoring, Evaluation, and Reporting

Develop and implement a monitoring and evaluation framework to track progress and impact.

### 3. RFQ RESPONSE REQUIREMENTS

Potential Service Provider must provide the following details in their response:

- 1. Company (Name, Address, Contact Person, Website, Years of Experience, Past experience etc.)
- 2. Pricing Schedule (Annexure A) (Itemized cost structure, travel, materials, and communication)
- 3. At least two reference letters (At least two references for work conducted as a company, reference must be on the letterheads of clients)
- 4. Company Registration Documents
- 5. BBBEE Certificate or Sworn Affidavit

#### 4. EVALUATION CRITERIA

Only bids that have submitted the required documentation in Section 4: RFQ Response Requirements, will be evaluated based on the below criteria.

- 1. BBBEEE Scoring (30%)
  - Level 1 = 30%, Level 2 = 25%, Level 3 = 20%, Level 4 = 15%, Level 5 = 10%, Level 6 = 5%, Level 7 + = 0%
- 2. Experience and references (20%)
  - 5% for each credible reference letter, with a maximum of 20% total
  - DWF reserves the right to verify references
